

### **ITEC Conference 2023**

The 28th Annual Inter-Tribal Environmental Council Conference was held July 25-27, 2023, at the Hard Rock Hotel in Catoosa, Oklahoma. The General Assembly opened with the presentation of colors being posted by the Cherokee Nation Color Guard and a performance by the Cherokee National Youth Choir. Opening plenary sessions focused on TEK Camp at the Cherokee Nation and a Cheyenne Arapaho Brownfields Documentary. Afternoon sessions were Passing the Seed Presentation and a Cultural Make and Take from Cherokee Nation Cultural Resources. For the first time this year, Hard Rock staff gave a tour of their sustainability efforts to attendees.







Thursday's session included another walking tour, a presentation from Dr. Cristi Eschler-Freudenrich on successful outreach and a short movie of Cultural Outreach from CN OSIYO TV.

There were approximately 185 attendees which included representatives from the Environmental Protection Agency, Region 6 Tribes, various tribal organizations, environmental consultants and environmental organizations. Equipment manufacturers also displayed their products and services at this year's ITEC Conference.







# **Director's Corner**

## Chieko Buffalo, Cheyenne & Arapaho Tribes

### Where is your Tribal community located?

The Cheyenne and Arapaho Tribes are located in Concho, OK. Our reserve is 35 miles northwest of Oklahoma City, OK. Our EPA office is a short mile down from our Administrative Building and government offices.

# How many community members are served by the environmental department?

Our tribe currently has 14K tribal members and we serve a majority of them that reside within our nine county jurisdiction.

### How long have you been the Environmental Director?

I started in the environmental program in the beginning of 2020 and have advanced to the environmental director this past year.

# What are the primary environmental concerns that affect your tribal community?

"Illegal dumping of debris and hazardous materials" – Governor Reggie Wassana



### As an Environmental Tribal Director tell us what you enjoy most about your work.

I love that we're doing our part to understand, help, restore and protect our sacred Mother Earth on our tribal lands.

### What have been your biggest challenges?

The biggest challenge is our illegal dumping. We are working towards cleaning up two major sites within our jurisdiction.

## **ITEC Training: Intro to Drones**

On August 7, 2023 ITEC held an Intro to Drones Course. There were 16 participants from Citizen Potawatomi, Cherokee Nation, Muskogee Nation, Comanche Nation, Apache Tribe, Delaware Nation, Kaw Nation and Peoria Tribe. in attendance. The training consisted of class-

room discussions on the components of registering a drone. Also, the steps involved in obtaining an FAA Drone Pilots License were discussed. The class also involved hands-on use and a demonstration of the drone outside the training facility.





## Lead Awareness in Indian Country: Train the Trainer

ITEC collaborated with the U.S. Environmental Protection Agency's Office of Pollution Prevention and Toxics to offer a Lead Awareness Curriculum Train the Trainer session on September 7, 2023. Fourteen participants gathered from varying Cherokee Nation departments such as: Environmental Programs, Office of Environmental Services, Head Start, Stilwell Child Development Center, and Housing Authority. Staff from Muscogee Nation and Thlopthlocco Tribal Town

were also present.

In just three hours, participants discovered straightforward actions to

minimize lead exposure, gained familiarity with the comprehensive EPA Lead Awareness Curriculum, learned how to tailor the curriculum to their community's unique needs, and developed a plan for hosting sessions in their community. The Lead Awareness Curriculum consisted of educational tools tailored for community leaders experienced in educating and training community members, or anyone passionate about advocating for lead awareness and child safety.



# Building Resiliency and Adapting to Climate Change Impacts for Drinking Water and Wastewater Facilities

The recent training event titled "Building Resilience to Climate Change: Tribal Water Sector Training" organized by the Environmental Protection Agency (EPA) and Cherokee Nation Environmental Programs provided a one-day immersive experience focusing on essential aspects of climate resilience, adaptation strategies, and tribal utility infrastructure financing. The training took place at the Hard Rock Hotel and Casino Tulsa on Tuesday, August 8, 2023.

The training aimed to equip participants with practical knowledge and tools to address the pressing challenges posed by climate change. It was designed for a diverse



audience, including owners, operators, practitioners, and environmental managers from tribal drinking water, wastewater, and stormwater utilities, as well as rural water districts serving tribal communities. Additionally, contractors servicing these utilities and other water sector stakeholders were encouraged to attend.

The event had several key objectives, including:

- Providing insight into how climate change threats impact tribal water utilities in the region.
- Introducing participants to valuable resources offered by the EPA's Climate Resilience for Water Utilities (CRWU) program, such as Climate Data Maps and the Resilient Strategies Guide (RSG), both web applications facilitating resilience building.
- Presenting a local utility case study to illustrate practical resilience planning and adaptation efforts utilizing CRWU tools and resources.
- Guiding utilities in using CRWU Climate Data Maps, RSG, and the Climate Resilience Evaluation and Awareness Tool (CREAT) for climate risk assessment and long-term resilience planning.

Offering an overview of tribal-specific resources for financing infrastructure projects and instructing attendees on applying for suitable funding programs.
